5. **Eligibility:** You may enter the Sweepstakes if you are a legal resident of the 48 contiguous United States or D.C. (void in Rhode Island and all U.S. territories, possessions, offshore commonwealths and military installations), 18 years of age or older and the age of majority in your state of residence at the time of entry. Void where prohibited, licensed, restricted or taxed.
