#### 1. Where can I find Grant Program guidelines?

#### 2. Who can apply?

Applicants can be for-profit organizations or non-profit organizations. For-profit and non-profit organizations must have a licensed general contractor, licensed builder or licensed architect retained as of the date of Application and continuing through the date of any Grant Award. Please note that Habitat for Humanity affiliates do not need to apply for a Grant in order to receive insulation, however they do need to make a formal request for insulation <u>here</u>.

## 3. How many Grants will be awarded?

At least one grant of UltraTouch™ Denim Insulation will be awarded. Additional Grants may be awarded at the discretion of Cotton Incorporated.

## 4. What is a community-based building?

A community-based building is a civic-oriented building that benefits a local to wide-ranging population such as performing arts centers, hospitals, children's museums, schools, libraries, community centers, etc.

#### 5. Can I submit more than one Grant Application?

Yes, once you submit an Application, you may submit another Application provided it is for a different project/building.

## 6. If I am a Grant Award recipient, when will I receive my UltraTouch™ Denim Insulation?

After being notified that you are a Grant Award recipient and your eligibility is verified and you complete, sign and return a Copyright License and Affidavit of Eligibility, Ownership and Liability Release, we will contact you to coordinate delivery.

# 7. What costs am I responsible for if I am the recipient of a Grant Award of UltraTouch™ Denim Insulation?

There is no cost for the UltraTouch™ Denim Insulation. We will schedule a delivery date in coordination with you and, provided this date is not changed by you, one-way shipping of the UltraTouch™ Denim Insulation will be included as part of the Grant Award. If the originally scheduled shipping date is changed by you, then you will be responsible for the shipping of the UltraTouch™ Denim Insulation. All costs associated with storage, installation, additional shipments or any other costs once the awarded UltraTouch™ Denim Insulation is delivered will be the responsibility of the Grant Award recipient. We are required by law to report to the Internal Revenue Service the retail value of your organization's Grant Award(s) received from Cotton Incorporated. Your organization will receive a copy of this documentation and will be
